RE: B-On-Time (BOT) FY 2018 Reallocation Calculation

The chart below shows the reallocated BOT funds that will be distributed to both public and private institutions that submitted a reallocated request form by February 20, 2018. The reallocation amounts were calculated using initial allocation percentage shares in accordance with the program rules. No institution will receive funds in excess of the requested amount. Disbursement of funds on certified loans must be made no later than **May 4, 2018**. Any funds not disbursed by the deadline date will be forfeited by the institution.
