RE: FY 2016 and FY 2017 Bilingual Scholarship Program Request Form

The FY 2016 and FY 2017 Bilingual Scholarship program request form is now available. The purpose of the Bilingual Scholarship program is to encourage students to enroll in an educator preparation program at a university to become certified to teach in school districts with high critical needs. These teacher certification areas include bilingual education, English as a Second Language (ESL), or Spanish.

A one-time appropriation of excess funds for costs associated with bilingual education programs will be distributed to eligible institutions which include the University of North Texas, University of North Texas at Dallas, Texas Woman's University, University of Texas at Dallas, University of Texas at Arlington, Texas A&M-Commerce and the Texas Tech University- TechTeach Program in the Dallas Fort Worth area.

Each eligible institution must submit to the Texas Higher Education Coordinating Board (THECB) a request for the amount of funds they are able to spend in FY 2016 and FY 2017, not to exceed \$150,000 per fiscal year. A request form must be completed and emailed by **August 1**, **2016** to DeCha.Reid@thecb.state.tx.us.

The THECB will review excess funding from the Top Ten Percent Scholarship program by October 15, 2016 to determine total funding available to each eligible institution for the Bilingual Scholarship Program. An additional memo will be disseminated to announce the official program amounts for FY 2016 and FY 2017.

The THECB will review excess funding from the Top Ten Percent Scholarship program by October 15, 2016 to determine total funding available to each eligible institution for the Bilingual Scholarship Program.

If the total requested amounts from the eligible institutions do not exceed the total excess funding identified by the THECB, then each eligible institution will receive a distribution equal to the requested amount.

If the total requested amounts from the eligible institutions exceed the total excess funding identified by the THECB, then each eligible institution will receive a share of the total excess funding based on the percentage of the institution's requested amount.
