This memo is to announce the enclosed final allocation amount for
Bilingual Education Scholarship program for the 2017-18 academic year.

The purpose of the Bilingual Education Scholarship is to provide
financial incentives in the form of tuition assistance, to encourage students
who enroll in an educator preparation program at the university to
become certified to teach bilingual education, English as a Second
Language, or Spanish in school districts with high critical needs.

Participation in the Bilingual Education Scholarship program requires that
institutions submit a report no later than January 1, 2019 to the Texas
Higher Education Coordinating Board (THECB) detailing annual
information on performance measures. Disbursements for the Bilingual
Education Scholarship funds will be issued the first week after the first
day of the new fiscal year, September 1, 2017. Unused funds cannot be
carried between fiscal years and must be returned to THECB.
